For how long would it require for ChatGPT to challenge the hallowed tradition of scholarly scrutiny and validation — the peer review system? Never!

While there is a constant debate surrounding whether artificial intelligence (AI) is capable of fully replacing human peer reviewers or not, it is being used to assist with certain aspects of the [peer review process](#). For example, some publishers are using AI tools to screen submissions for plagiarism or to identify potential conflicts of interest. Other publishers are using AI to help identify suitable reviewers based on their areas of expertise and past performance.

Peer review is not immune to scientific misconduct since some reviewers may distort study findings intentionally or accidentally. Because of these constraints, several academics are investigating the use of AI tools and chatbots, such as ChatGPT, to aid in the peer review process. However, the extent to which AI can completely replace human reviewers still remains a subject of debate.

The STM industry focuses on making an informed judgment about its use in peer review and establishing some policies. Wiley, Hindawi's parent company, found over 1,200 papers with altered peer reviews, largely from special issues, to be retracted in order to combat scientific misconduct and assure ethical scholarly publishing. This comes after the retraction of 511 articles from 16 journals in 2021 for the same reason. The discovery was made as a result of the same research that resulted in the initial retraction.

Could ChatGPT-generated Text Deceive Reviewers and Readers?

ChatGPT raises concerns about its potential to deceive readers and reviewers. As AI algorithms improve, it is critical to study whether the use of ChatGPT-generated text can result in biased or incorrect information and how to prevent these difficulties.
